

**OXFORDSHIRE COUNTY COUNCIL
(GROVE AREA) (SPEED LIMITS) ORDER 20****

Oxfordshire County Council (“the Council”) in exercise of its powers under Sections 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order and may be cited as the Oxfordshire County Council (Grove Area) (Speed Limits) Order 20** and shall come into force on the day of 20**.
2. No person shall drive any vehicle at a speed in excess of 30 miles per hour in any of the lengths of road specified in Schedule 1 to this Order.
3. No person shall drive any vehicle at a speed in excess of 50 miles per hour in the length of road specified in Schedule 2 to this Order.
4. No speed limit imposed by this Order applies to a vehicle falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011, being a vehicle used for naval, military or air force purposes, when used in accordance with regulation 3(5) of those regulations.
5. The Oxfordshire County Council (Grove Area) (Speed Limits) Order 2011 is hereby revoked.

SCHEDULE 1

30mph Speed Limit:

1)

The whole length of every road in the Parish of Grove extending, in the case of such roads leading out of the said Parish, to the following points:

Oxford Lane	to a point 53 metres west of its junction with the A338
Denchworth Road (north of Grove)	to a point 51 metres northwest of its junction with The Maples
Denchworth Road (south of Grove)	to a point 12 metres south of its junction with Newlands Drive and Cane Lane to its roundabout junction with Mably Way

*** Kingside to its junction with the A338 Station Road**

- A338 Station Road to a point 92 metres north of its junction with Main Street
- A338 Grove Road southwards to a point 140metres north of its junction with Harcourt Way, Wantage.

(* Subject of previous consultation Nov.2016 – yet to be finalised)

2)

- (a) A417 Mably Way Between its roundabout junctions with Denchworth Road, Grove / Wantage and the A338 Grove Road.

SCHEDULE 2

50mph Speed Limit:

A338 Wantage - Oxford Road extending (in Station Road):

from a point 92 metres north of its junction with Main Street, Grove, north-eastwards	to a point 80 metres south west of its junction with Summertown, East Hanney.
