**The Oxfordshire County Council,
Chadlington Footpath No. 5 (part) and Chadlington Unrecorded Footpath
Public Path Extinguishment and Definitive Map and Statement
Modification Order 2020**

This Order is made by The Oxfordshire County Council ('the authority') under section 118 of the Highways Act 1980 because it appears to the authority that the footpath described in paragraph 1 below is not needed for public use.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement of Public Rights of Way for Oxfordshire requires modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the extinguishment (as authorised by this Order) of highway shown or required to be shown in the map and statement.

West Oxfordshire District Council has been consulted as required by Section 120(2) of the Highways Act 1980.

BY THIS ORDER:

1. The public right of way over the land situated at Chadlington and shown by a bold continuous line on the map attached to this Order and described in Part 1 of the Schedule to this Order shall be extinguished from the date of its confirmation, and thereupon the Definitive Map of Public Rights of Way for Oxfordshire shall be modified accordingly, and the Definitive Statement shall be modified as described in Part 2 of the Schedule to this order.
2. Notwithstanding this Order, statutory undertakers with apparatus over/under the land described in Article 1 above shall continue to have the same rights in respect of such apparatus as they had immediately before the date of this Order.

Unrecorded Footpath:

The entire width of unrecorded footpath running NE for approximately 44m from the public highway leading to Lower Court Farm at OS Grid Ref SP 3245 2128 (Point A on the Order plan) across the garden of Old Forge to Chadlington Fp 5 at SP 3248 2131 (Point B).

Chadlington Fp 5 (part):

The entire width of Chadlington Fp 5 running NE for approximately 135m from the unrecorded footpath at OS Grid Ref SP 3248 2131 (Point B on the Order plan) to SP 3256 2141 (Point C).

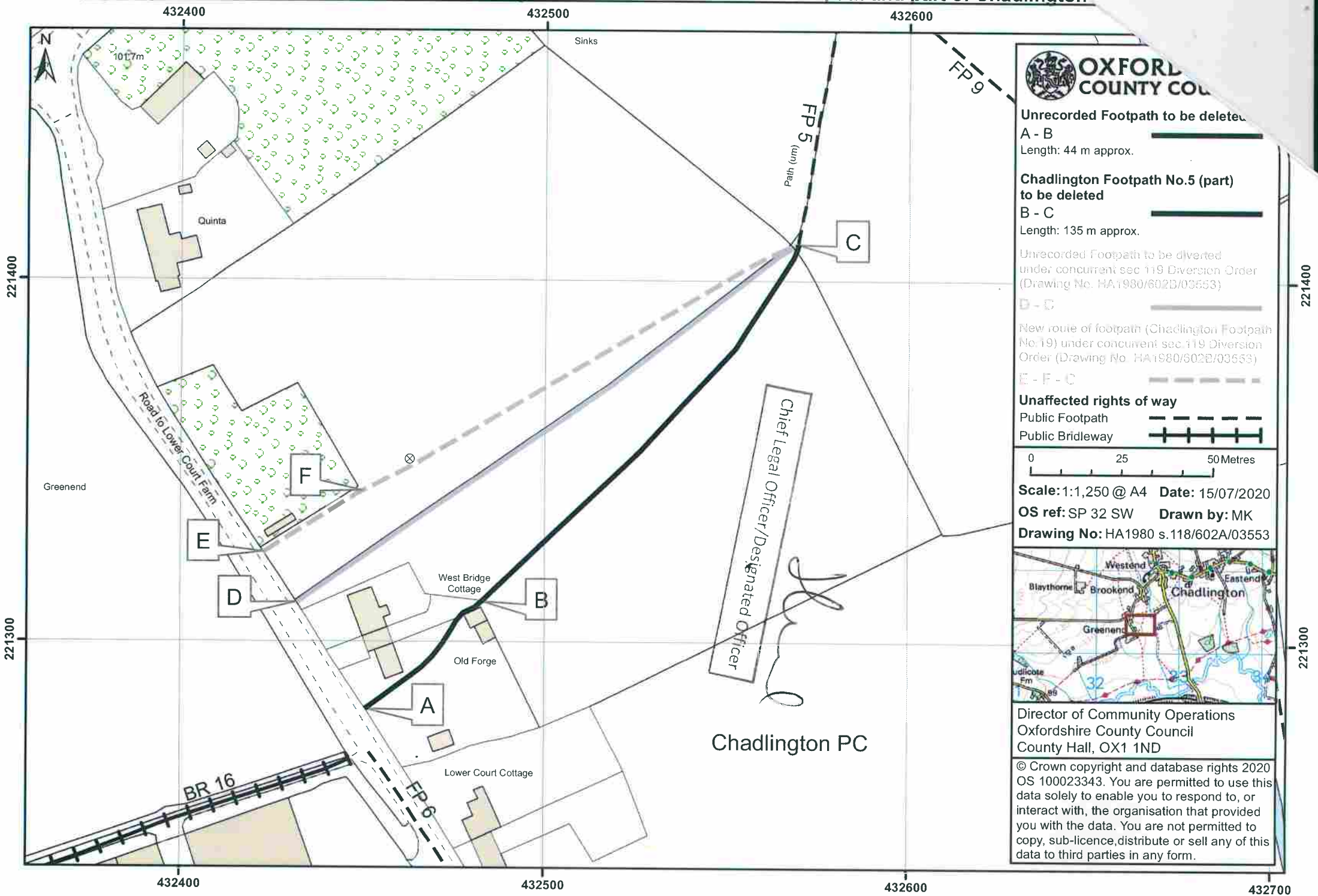
